a. Website

b. HPNA only:

- i. Over the past thirty days, there were 3 motor vehicle thefts (all hyundai or kia)
- ii. Three burglaries in the area: lower Mt Vernon, Caroline St, Meigs St.
- iii. Pac-tac: Lt Wilson is hoping to schedule pac-tac training, which will probably be Section-wide. Roger and I can start walking again. Lt Wilson requests a day's notice.
- iv. Aggravated Assaults (Diem & Goodman): No further info at this time.
- v. Carbeat 265: Most of 265 is south of I-490. Trend-wise there is little crime activity of significance in the HPNA area.
- vi. Vehicle larcenies: In addition to electronics, larcenies occur to get at athletic gear / sunglasses.

c. Community Relations Unit:

- i. Capt Person introduced himself.

- iii. Goodman Section Crime Stats:
- iv. The Goodman section essentially goes from Highland Park to Clifford Ave, and the river to the city boundary, covering the east side of the city.
- v. See the crime map link info below to get a visual layout.
- vi. 22 of 23 car larcenies were "entry without break-in", meaning that the cars were left unlocked.
- vii. Goodman section realignment target date: Sept 11, 2023.
- viii. Although Kia/Hyundai vehicle thefts continue, the associated burglaries are down. Tends indicate that the stolen cars are not so often being used to break into storefronts. The RPD does not pursue stolen Kia/Hyundais unless there is another serious crime involved.
- ix. Staffing issues continue unabated. RPD is down 100 officers. 9 graduated from the academy. 6 retired. There are RPD officers on 16-hour days in order to cover shifts. Closing date for new applicants: 884 applied. Must be vetted. Experience indicates that at every step, remaining applicants are ½ of the previous step. Many candidates drop out due to physical fitness, approx ½. Budgeting for 50 applicants to put on the uniform.

 - i. Can look up properties that are rented and whether they are not owner occupied and if they have low scores and what their issues are with violations.
 - ii. Contact information available for owners
 - iii. Not enough code enforcement officers to address property issues. Have caseloads of 400+ properties per person
 - iv. Issues/Violations populated by NSC and Code Enforcement Officers
- d. Input from Code Enforcement regarding updated fines and enforcement actions
 - i. Fines will be issued immediately for Health and Safety and within 30 days for anything else.
 - ii. Increase of \$250 and goes to \$500 if immediate hazard. Moves quicker and less to track.
 - iii. No more 60 day periods to remedy violations. Must be fixed in 30 days.
 - iv. Effective Jan 1 there's a vacant building registry if it's over 60 days and that costs a fee to register the building. Vacant properties cost the owners to incentivize renovation.
 - v. LLC's must disclose who the owner is too.
- e. Bring Code Enforcement Officer to a Board Meeting or General Meeting due to interest in process and questions about enforcement
