Goodman Section Crime Stats: In general, things calming down. The Goodman section covers approximately 40% of the city. This PCIC meeting covers neighborhoods that represent approximately 20% of the city.

- Burglaries: Up compared to last year. With covid in the past, people are home less. Two types: entry
 without break, e.g. doors left unlocked; forced entry, e.g. broke a window. Currently trending about 50%
 / 50%. Often the perpetrator simply tries doors to see if they are unlocked.
- Robberies: about the same as last year
- Aggravated Assaults: South part of Goodman section is safest in city.
- Larcenies: trending down in the south part of Goodman section.
- Definition: Strong Arm Robbery criminal uses some physical force, e.g. rips purse off shoulder, but does not employ a weapon.
- Car larcenies: car was typically unlocked. People are leaving their car running with the keys in the car. Much more a case of just trying doors, and then finding something of value (purse, phone, etc).

Bordering HPNA: Homicide at Towers at Clinton S and Goodman. Two people who know each other. An arrest has been made.

HPNA only (over the past thirty days)

- Burglary: 2 in area. Entry w/o break. Caroline St. & Menlo Pk.
- Various larcenies: 5 in area. Typically, valuables are left visible in cars, or public accessible places. In addition to electronics, larcenies occur to get at athletic gear / sunglasses. Don't leave items in plain sight. Lock doors.
- Motor Vehicle Theft: In other areas, it is Hyundais and Kias primarily. RPD has arrested two adults and two juveniles. Don't leave car fobs in the vehicle.

Southeast Neighborhood Service Center: Regarding HPNA, nothing specific to report.

Homeless detail will be out every Thursday, trying to get people services.

Crime Prevention Officers will be at the Lilac Festival, so if you need to call, you might have to leave a message. CPO's do not take 911 calls.

So far in 2024, the CPOs / NSC have issued as many nuisance points as in all of 2023.

- Have you written down the serial numbers of major appliances, electronics, etc? These are extremely useful to the RPD as they query pawn shops, etc during the investigation.

5. Other / New Business

- a. Elwanger & Barry Playground Sandbox
 - Sandbox has been repaired by the City and partially filled. Roxanne has agreed to order more sand for the city to install in the sandbox.
- b. HPNA Banners
 - Canvas banners to replace those that are missing are approximately \$250/ with hardware. RGE was hesitant to agree to install them. Bob made a suggestion to take those banners that are currently in place or available to install and install them at positions entering the HPNA area and forego replacing every banner.

County would be producing / installing them and gave Larry specifications (shared with the board via email) but did not estimate cost as the County wanted to know how many signs would be involved. Larry & Bob will count the signs when walking PacTac next week. Hopefully, the County can then provide an estimated cost. More discussion in the June meeting on this.

 - Approximately 13 folks volunteered to clean up the S. Clinton garden (near the Artisan Church) Their help was greatly appreciated.
